Counseling Services: Professional therapy for children, families, and individuals. 193 clients received over 1,927 hours of therapy. We were able to serve 28% of our clients on a sliding fee scale which directly allows low income families without Medicaid to receive counseling. The counseling department staff feel lucky to be able to witness human beings reach their potential every day as they become the best versions of themselves.

LifeStart Village: Housing and self-sufficiency program for homeless single parents and their children. 175 individuals were served across all three phases of the program. Over 373 hours of case management and 278 hours of counseling were provided. The overall objective of LifeStart Village is to move single parents with children from dependency to self-sufficiency.
